President's Message



2017 saw another busy year for the Institute. We began leading the implementation of a major project for the UK Foreign and Commonwealth Office, designed and led by our Programme Director Gabriel Oosthuizen. We provided our first training on investigating Sexual and Gender Based Violence aimed specifically at peacekeepers, and a new International Investigation Team Leader Course was introduced. All this under the leadership of Executive Director Philip Trewhitt. We have been very pleased to welcome more staff from the International Criminal Court this year, both as participants at the training and as trainers themselves. This is a real benefit to both organisations.

Early in 2018 we lost a beloved founding member, Lt. General Gerard McMahon, former Chief of Staff of the Irish Defence Forces. General McMahon designed and wrote the military module of our training, and for the first few courses taught it, before Colonel Desmond Travers took the reins. We relied on General McMahon's wise and practical counsel, his steady example as a leader, and his warm and witty personality. His passing was a great loss to his family, to us, his old comrades, and to the international community. We extend our deepest condolences to his family and friends. On a happier note, we welcomed back our former Executive Director, John Hunter Ralston, this time as a member of the Board of Directors. We look forward to working with him again with much enthusiasm.

We also take this opportunity to send our congratulations and best wishes to our friend and colleague Andras Vamos-Goldman, Executive Director of Justice Rapid Response (JRR), who retires in 2018 from that post. We have been strong allies with JRR in delivering training for their roster of investigators from all over the world, and Andras was untiringly at the forefront of building that roster. His energy and commitment were boundless. We welcome his successor, Ms. Nina Suomalainen, and look forward to working with her to ensure that the international justice community has the very best people available.

2018 is another busy year - another new course coming on stream (Financial Dimensions of War Crimes Investigations), as well as the second portion of our major project for the UK government. It should be an interesting year for IICI. Every other one has been.

OVERVIEW

The Institute for International Criminal Investigations (IICI) is an international, not-for-profit, non-governmental organisation, dedicated to the training of investigators and related professionals from international tribunals, the UN and other inter-governmental organisations, national authorities and civil society in the investigation of war crimes, genocide, crimes against humanity, and egregious human rights violations.

IICI runs a regular training programme in The Hague, consisting of its international investigator course and a number of specialist skills courses. Additionally, IICI responds to specific requests from national and international bodies and civil society to conduct tailored training worldwide. We operate in some challenging environments, and we appreciate the dedication of

our regular training staff. In addition to our contracted trainers, IICI relies frequently on staff currently serving with international agencies and tribunals, most especially the **International Criminal Court** (ICC), the International Criminal Tribunal for the Former Yugoslavia (now United Nations Mechanism for International Criminal Tribunals or 'MICT') and other UN agencies. We recognise that taking time off from their heavy workload to assist us is not easy and would like to express our heartfelt thanks, both to them and in particular to the management of the institutions, for their continued support. It is invaluable.

IICI also is grateful to our core donors – the Oak Foundation and Sigrid Rausing Trust – for their continued and invaluable support, as well as project donors, particularly the Foreign & Commonwealth Office of the United Kingdom.

Highlights of IICI's 2017 programmes and activities

Regular Training Programme 1. 27th International Investigator Course (IIC27), 22 May – 2 June

There were 22 participants (over half being female) from 14 nationalities: 7 from human rights organisations and 15 from national authorities, international tribunals or agencies (including ICC and the UN). This course benefited enormously from the assistance provided, as always, by the Royal Netherlands Army School for

Peace Operations. A special thank you to their staff for this course.

2. Documentation of Scenes of War Crimes and Human Rights Violations Course (DSWC Course), 5 - 9 June There were 6 participants (over half being female) from 6 nationalities: 3 from human rights organizations and 3 from national authorities,

international tribunals or agencies (including ICC and the UN).

3. Analysis Skills Course (ASC), 19 – 23 June

There were 9 participants (over half being female) from 9 nationalities: 3 from human rights organizations and 6 from national authorities, international tribunals or agencies (including ICC and the UN).

4. 28th International Investigator Course (IIC28), 6 -17 November


There were 21 participants from 15 nationalities (half being female): 7 from human rights organizations, 7 from international tribunals or government agencies (including ICC and the UN) and 7 from national law enforcement units, many of whom are facing increased workloads with the return of their nationals from Iraq and Syria following involvement with the so-called 'Islamic State'.

5. Investigative Interview Skills Course 23 - 27 October There were 10 participants (over half being female) including from 6 nationalities; 6 from human

rights organizations and 4 from national authorities, international tribunals or agencies (including ICC and the UN).

6. International Investigation Team Leader Course (ITLC), 20 -**24 November** It is part of IICI's remit to fill the skills gaps which exist at the international level. While there is plenty of management training available, being an international investigation team leader is a unique position and one for which no training existed previously. In November 2017 we designed and ran a course to remedy this, bringing together national police officers, OHCHR staff, ICC investigators and civil society to learn about investigation planning, prioritization of resources, handling staff, conflict and security crisis management and personal dynamics. There were 11 participants (nearly half being female) from 7 nationalities: 2 from human rights organizations and 9 from national authorities, international tribunals or

agencies (including ICC and the UN).

In addition to our regular courses, IICI also has a range of specially designed courses for national authorities, international organisations and civil society worldwide. The courses depicted in the map are a sample of the 26 trainings we have conducted over the last several years (see Annex 1 for a full list).

2017 Courses:

- 1. London: Mentoring country specific participants on documentation of conflict-related sexual violence (further details withheld for security reasons)
- **2. Dublin:** From 3-7 July, a pilot training course was jointly organised by the Defence Forces Ireland (DFI) and the IICI to enhance the capacity of Irish

Military Police investigators and other relevant professionals acting under UN peacekeeping mandates - to investigate and/or document atrocities. The course focused specifically on conflictrelated sexual and gender-based violence (CRSGBV), although many of the modules were equally applicable to other types of crime. While Sexual Exploitation and Abuse (SEA) was addressed, it was not the main focus of the course. Observers from the British and Swedish militaries attended, in addition to UN DPKO. The focus of this course was on applying an SGBV lens to investigations, providing the necessary additional skills and emphasizing the challenges of conducting such investigations

in a post-conflict environment with resource limitations.

- **3. Hague, Netherlands:** Training course for 15 staff of an international agency (further details withheld for confidentiality reasons).
- 4. Liberia: Training and mentoring to strengthen the investigating capacity for staff of the Global Justice & Research Project (GJRP). The workshop was co-organised with GJRP and Civitas Maxima and took place in August 2016 in Monrovia. The workshop built on IICI's previous work with Civitas Maxima and GJRP, whose investigations have been used by Swiss, Belgian and US authorities to investigate and prosecute alleged Liberian perpetrators of atrocities. This impressive achievement has now been augmented in 2017 with the arrest by UK police of Agnes Taylor, wife of former Liberian president Charles Taylor, on charges of torture, following an investigation for which GJRP provided the initial information.

<u>Justice Rapid Response</u>

5. Seoul: JRR-UN Women training course on "Investigating Sexual and Gender-Based Violence as International Crimes" 13 - 28 April

There were 25 participants (over half being female) from 22 nationalities.

6. Hague: JRR-IICI Advanced
Training Course on the

Violations Involving Children 48 December This joint project

capacity for investigating crimes
and violations involving

Implementing projects

In 2016 IICI designed, bid for and was awarded an SGBV training and mentoring project over two years with IICI as lead implementing partner. The project, carried out in conjunction with JRR and REDRESS, focuses on strengthening the SGBV investigation skills of civil society in/from a number of countries, including Sri Lanka, Myanmar, Uganda and Iraq. Several training, mentoring and remote mentoring activities were implemented in 2017. For security reasons, specific details are withheld.

Looking ahead to 2018: At the end of 2017, IICI looks back on a year where we provided our full range of courses in The Hague, two JRR courses, and two specialist courses in The Hague and Liberia; we developed and implemented the first two of our new regular courses, focusing on investigation team leadership and evidence gathering/preservation by peacekeeping contingents; and we very successfully led implementation of a large, complex project in four countries with deteriorating security or political environments. We also invested significantly in a new website and communications, as well as in internal processes. This has only been achieved through the dedication and professionalism of the IICI core staff, trainers

and mentors and IICI extends grateful thanks to them all. In 2018, our focus will include the completion of the FCO project and the development of new courses to meet the expanding needs of the international community, principally Financial Dimensions of War Crimes Investigations and Open Source investigations.

IICI trainers and mentors are all people with significant field experience and a real commitment to international justice. In November 2017, Ratko Mladic was sentenced to life in prison for genocide and war crimes during the Balkan conflict. It was a proud moment for the Institute as no less than 10 IICI current and former trainers had worked on the case at various stages. We salute their dedication and professionalism.

No other organisation provides the range of advice and expertise to the community we serve. The feedback we receive suggests not only that our work is important, but that IICI is indispensable. We will continue to develop and evolve to ensure we stay that way.




